Cooley Adds IP Pros From Pillsbury, MoFo To Calif. Offices

Ghajar has extensive experience in trademark and copyright litigation, including representing Facebook Inc.'s Oculus VR Inc. last year in a trademark suit initiated by a video hosting service called Oculu LLC. A judge held that the goods and services offered by the two companies were far too different for consumers to be confused by similar names. The suit received an honorable mention in Law360's list of the top trademark rulings of 2015.

"Cooley's trademark, copyright and advertising group is incredibly strong, with one of the busiest IP dockets in the country and advises not only the world's largest companies, but the next generation of exciting, emerging companies," Ghajar said in a statement. "I'm eager to contribute toward its continued global success."

Mayer received her undergraduate degree from the University of Arizona and her law degree from
