TOP INTELLECTUAL PROPERTY ATTORNEYS in California for 2016

Patent prosecution, portfolio management



u's education in medicine has propelled her into the world of medical company patent protection. She holds a medical degree from Beijing Medical University and a Ph.D. in molecular biology, cell biology and biochemistry from Brown University, and was a research fellow at Harvard Medical School.

Wu advises medical device company Abaxis Inc. in its patent protection strategies. Her work includes filing and obtaining patents in the United States and internationally.

She implements out-licensing strategies to strengthen the company's patent status. This has translated into millions of dollars of royalty revenue for Abaxis.

A major facet of Wu's work involves managing patent portfolios.

"We'll build the portfolio to represent their business story," she said. This portfolio shows competitors how her clients are protecting their patent-controlled assets.

Wu is also the primary patent portfo-

lio architect for clinical-stage biopharmaceutical company Ultragenyx Pharmaceutical Inc. in Novato, which went public in 2014 and had another offering last year.

She conducted patent due diligence review for various patent portfolios licensed by the company.

Wu manages and focuses these portfolios to obtain strategic patent coverage for products Ultragenyx is interested in and to support their business objectives.

When Wu advises venture capitalists on intellectual property issues and portfolio assessment, she tells them that risk analysis is key.

"The legal world is full of uncertainty," Wu said. "That's why they need good attorneys to analyze risk. There's always risk; it's how to manage that. It's teamwork between business team and legal team."
