Robert is a commercial litigator and corporate risk advisor, and leads Cooley's insurance group. As part of his policyholder practice, Robert has placed coverage for and handled more than \$1 billion in claims under various types of insurance and reinsurance policies, including cyber, management liability (D&O), fiduciary liability, commercial general liability (CGL), environmental, product recall, professional liability (E&O), kidnap and ransom (K&R), property/business interruption, builders' risk, representations and warranties (R&W), and tax liability.

Robert assists clients from a range of industries – including tech, life sciences, chemical, energy, financial services, private equity, higher education, consumer products, agricultural and automotive. In addition to his insurance practice, Robert also has handled a variety of other litigation and advisory work, including administrative, bankruptcy and product-liability litigation.

Before beginning private practice, Robert clerked in the US Court of Appeals for the Fourth Circuit and the US District Court for the Southern District of Georgia and has since worked at two other major international law firms in Washington, DC. Robert holds a Certification in Risk and Information Systems Control (CRISC) and designations as a Chartered Property Casualty Underwriter (CPCU), Associate in Claims (AIC), Certified Information Privacy Professional (CIPP/US), Certified Information Privacy Manager (CIPM) and Certified Information Privacy Technologist (CIPT).
