Shamis focuses her practice on complex commercial litigation, white collar criminal defense, government investigations and appellate matters. Shamis represents companies in highly regulated industries in government investigations, including Department of Justice (DOJ), Consumer Product Safety Commission (CPSC) and state attorneys general investigations. She also regularly manages whistleblower investigations. She helps clients successfully navigate regulatory and litigation risk and advises clients on all aspects of civil and criminal investigations, including managing broad civil investigative demands and subpoenas. In addition, Shamis has broad experience managing civil litigation at the trial level and on appeal. She has a strong track record of representing clients in cases concerning product safety, consumer protection, child safety and data privacy, and in cases arising under the Anti-Kickback Statute (AKS) and False Claims Act (FCA).

Shamis also maintains an active pro bono practice. She works on civil rights and criminal justice matters, including habeas petitions for defendants facing capital punishment, and with the New England Innocence Project. She previously represented a single mother accused of violating Section 5 of the Securities Act of 1933 for selling unregistered securities, advocated on behalf of two children fleeing gang violence in El Salvador, and represented a nonprofit organization dedicated to improving the lives of survivors of human trafficking and sex slavery. In addition, she has successfully represented clients in Hague Convention child custody cases at trial and on appeal.

Before joining Cooley, Shamis served as law clerk for US Circuit Judge O. Rogerie Thompson of the US Court of Appeals for the First Circuit and US District Judge Denise Casper of the US District Court for the District of Massachusetts.
