Her Yale Law Journal note on the history of civil rights litigation in Puerto Rico was reprinted in the 35th volume of the Civil Rights Litigation and Attorney Fees Annual Handbook (Steven Saltzman ed., 2019) and translated into Spanish in the 56th volume of the Inter American University of Puerto Rico Law Review (2022).

Before law school, Valeria was an editorial fellow and freelance writer at The Atlantic and interned at the American Civil Liberties Union of Massachusetts.
