He also has extensive experience litigating cases arising from corporate acquisitions and other major corporate transactions. He has handled such cases in Delaware courts as well as other courts around the country.

John also has substantial antitrust expertise. He has represented major US and foreign corporations in criminal antitrust matters involving the US Department of Justice and other competition authorities around the world. He also has substantial expertise representing such clients in civil antitrust litigation.

In addition to representing clients in federal and state courts, John regularly advises public and private companies and their officers and directors on a broad range of issues regarding fiduciary duties, disclosure matters, litigation strategy and compliance matters. He has also conducted numerous special investigations into allegations of possible misconduct on behalf of corporate boards and board committees.

Regulation FD. Also in 2005, a major pro bono litigation brought and won by John on behalf of legal immigrants against the United States Department of Justice and Department of Homeland Security was recognized by the National Law Journal as one of the top four pro bono cases nationally.

Prior to joining the Firm, John served from January to December 1997, as the acting associate attorney general for the US Department of Justice. He was selected for the post, the third highest in the Department of Justice, by President Clinton. As acting associate attorney general, he oversaw the Department's Antitrust, Civil, Environment and Natural Resources, Civil Rights and Tax divisions. From 1993 to 1997, John served as deputy associate attorney general. In that capacity, he served as a senior advisor to Attorney General Janet Reno on a wide variety of civil and criminal enforcement issues and acted as a primary liaison with the White House Counsel's Office. Prior to attending law school, John worked as an auditor at Arthur Andersen & Co.
