Kimberley also maintains an active pro bono practice, working on matters involving wrongful convictions, racial justice and immigration appeals.

Kimberley's recent and current matters

- Secured a complete reversal from the US Court of Appeals for the Federal Circuit of a district court's preliminary injunction on behalf of an international medical device company in a trade secret case
- Successfully rebutted the presumption of reliance at the class certification stage, resulting in dismissal of the second-largest stock drop from the case, in a securities class action against a pharmaceutical company
- Won a multimillion-dollar earnout payment for former shareholders of a patient engagement software company after accounting arbitration
- Won summary judgment for former shareholders of a medical software company in arbitration regarding a buyer's breach of a merger agreement for failure to release funds
- Secured a complete dismissal of a securities class action against an international biopharmaceutical company
- Secured a termination letter from the Securities and Exchange Commission ending an investigation into potential Foreign Corrupt Practices Act violations for an employee of an international technology company

- Secured a reversal of an immigration judge's decision denying a claim of fear of persecution for a citizen
 of Ecuador
- Representing the American Society for the Prevention of Cruelty to Animals in an Administrative
 Procedure Act petition challenging the federal government's enforcement of the Animal Welfare Act

- Represented former US state chief justices and chief judges in an amicus brief on the Second Amendment in the US Supreme Court
- Represented former US governors in an amicus brief on racial and political gerrymandering in the US Supreme Court
