As the son of war refugees, Matt centers his pro bono practice on strengthening civil rights, racial justice and the rule of law.

Fiercely committed to public service, Matt concurrently serves as a U.S. Army Reserve Captain Judge Advocate assigned to the 304th Combat Sustainment Brigade. Over the past decade, he has advised senior government leaders—the Biden-Harris campaign and transition; then-Senator Kamala Harris; then-House Speaker Nancy Pelosi; Secretary Jennifer Granholm; California Governors Gavin Newsom and Jerry Brown; and the USAID Representative to the European Union—on novel legal and policy issues. And following law school, Matt clerked for Justice Goodwin Liu on the California Supreme Court.

With the support of the Paul & Daisy Soros Fellowship, Matt graduated from Yale Law School as a Coker Fellow teaching torts and legal writing, notes & comments editor of the Yale Law Journal, and managing editor of the Yale Law & Policy Review. During this time, Matt directed the Education Adequacy Project Clinic, litigating constitutional challenges to school segregation, funding disparities, and the school-to-prison pipeline in the Connecticut Supreme Court and federal district courts. He also coauthored a book chapter with the Solomon Center for Health Law & Policy, and was a founding member of the We Care Coalition and the Immigration Policy Tracking Project. Matt graduated salutatorian from UC Berkeley.

In addition to military service and pro bono advocacy, Matt has served on public and nonprofit boards, including as co-chair of the Coast Community College District Oversight Committee, where he stewarded \$700 million in long-term education investments on behalf of students, faculty, and local stakeholders. In 2020, Matt was named to the Forbes 30 Under 30 list in the Law & Policy category. During his free time, Matt enjoys global travel, snowboarding, volleyball, golfing, and exploring with his Shiba Inu.
