Alex's representative matters include:

- Defending a startup cybersecurity company against claims it misappropriated data related to inbound email threats through hiring employees from a legacy industry player
- Defending a biopharmaceutical company against claims it misappropriated a confidential drink formula after a busted deal\*
- Defending a startup medical device company against claims it misappropriated proprietary techniques and technology through hiring employees from a rival company\*
- Representing an investment firm in an investigation into allegations of misappropriated customer information stemming from hiring employees from a rival firm\*
- Advising on various trade secrets investigations and litigations as counsel for the plaintiff or defendant, involving issues including trade secret ownership, public versus nonpublic information, and lost profits damages
- Representing an owner of horse racing tracks from claims of defamation and breach of contract by a banned thoroughbred trainer through victory at trial\*
- Defending employees of an oil field operator after an oil spill from government investigators and a private class action leading to no action taken by the government\*
- Defending numerous technology and life sciences companies in investigations brought by the DOJ and SEC
- Advising companies regarding practices related to protection of their trade secrets and other valuable information

Alex also maintains a robust pro bono practice. Highlights include victory at trial and through appeal for the largest class of Medicare patients in a matter concerning their right to reimbursement for necessary medical expenses and winning summary judgment for unhoused individuals against the city of Seattle in a matter concerning enforcement of camping regulations.\* He also has handled various immigration matters and

tenant-landlord disputes.
