Eduardo has played key roles on trial teams in major commercial disputes, securing favorable outcomes in consumer fraud class actions, contract litigation and fraud-related claims. He also has significant experience in intellectual property litigation, having defended innovative companies in patent and copyright matters, including obtaining complete dismissal of a copyright suit against a video game developer and defending medical device companies in competitor-driven patent cases.

In addition to his commercial practice, Eduardo is deeply committed to pro bono advocacy. He successfully represented asylum seekers and immigration clients, secured justice for a San Francisco prisoner subjected to excessive force, and served as counsel in a landmark class action challenging the Trump administration's 2017 travel ban. More recently, he secured injunctions on behalf of the San Francisco Unified School District against an agency order seeking to withhold federal funding pursuant to a 2025 executive order by President Donald Trump; and three members of Puerto Rico's Financial Oversight and Management Board challenging their firing in 2025 by Trump.

Eduardo's public service includes his prior role as a commissioner on the San Francisco Board of Appeals, a quasi-judicial body that reviews city permitting and enforcement decisions – experience that deepens his understanding of administrative law and public governance.
