- Halley Rise 3.5 million square feet of mixed-use development adjacent to the Reston Town Center metro station
- Reston Town Center a 450-acre, mixed-use space of more than 7 million square feet in the Town
   Center District located along the Dulles Toll Road in Fairfax County, VA
- The Spectrum at Reston Town Center a 750,000-square-foot office/hotel mixed-use redevelopment with 1,450 residential units
- Signature Site and Leidos HQ a mixed-use development containing 560 residential units, 40,000 square feet of retail space and a 200,000-square-foot office building for Leidos headquarters
- General Dynamics Corporation a corporate headquarters facility for the Fortune 100 company in Reston. VA
- StoneSprings Hospital Center a medical campus with a 164-bed general acute care hospital and 400,000 square feet of medical office space in Loudoun County, VA
- Reston Hospital Center 225,000 square feet of office space and a 152-bed expansion and enhancement of the medical campus in Reston, VA
- Tall Oaks Village Center Redevelopment of a 70,000-square-foot shopping center with 156 residential units and 13,500 square feet of retail space
