- Advising the world's largest clinical research organisation, IQVIA, in the successful defence of a High Court of Justice of England and Wales claim brought by Cardiorentis, a Swiss pharmaceutical company, for more than \$300 million in damages for alleged breaches of services provided in respect of a global clinical trial
- Acting for an American biotech company in relation to a successful claim brought in an International Chamber of Commerce (ICC) arbitration against a global pharmaceutical corporation in respect of the running of a clinical trial
- Advising various life sciences clients in respect of disputes relating to clinical trials, manufacturing and licensing
