**Frederick Baron** specializes in business litigation and prelitigation counseling, concentrating on representation of investment funds, life sciences and information technology companies, and chief executive officers. His practice has included litigation, arbitration and mediation in the areas of employment, trade secrets, contracts, investment fund realignments, board of director assessments, senior executive agreements, and employment issues in merger/acquisition transactions.

He has handled more than 35 criminal and civil jury trials and argued numerous appeals in both federal and state courts. Frederick regularly provides counseling on executive employment and separation matters, investment fund partnership matters, trade secret protection, employee raiding, noncompetition, whistleblowing, human resources policies and problems, and independent investigations for board of directors. He also conducts board of directors assessment processes for public companies to facilitate corporate governance improvements.

Frederick was appointed by Attorney General Janet Reno to serve as Associate Deputy Attorney General and Director of the Executive Office for National Security of the Department of Justice from 1995 to 1996, coordinating policy on international law enforcement and foreign intelligence matters. In 1992, Frederick served on President Clinton's presidential transition team. From 1980 to 1982, he was an Assistant U.S. Attorney for the District of Columbia, handling federal criminal prosecutions and special civil proceedings. From 1977 to 1979, Frederick served as Special Assistant to Attorney General Griffin Bell, with responsibility for foreign intelligence and counterintelligence matters. In 1976, he served on President Carter's presidential transition team. From 1975 to 1976, Frederick served as counsel to the U.S. Senate Select Committee on Intelligence.

Frederick was named to Best Lawyers in America (Management Employment Law, Individual Employment Law, and Employment Litigation), the Daily Journal's top employment defense attorneys in California, and Who's Who in American Law. He is currently named in Chambers USA Edition as a leader in Labor & Employment in California.
