She also maintains an active pro bono practice focused on asylum and immigration law.

Before joining Cooley, Bethany served as a law clerk to Judge Consuelo Callahan of the US Court of Appeals for the Ninth Circuit and now-retired Judge James Ware of the US District Court for the Northern District of California. She previously worked as a litigation associate in the San Francisco office of Morrison & Foerster representing clients involved in internet and other technology disputes in trial and appellate proceedings.
