#### Sam has represented clients in the life sciences and technology industries, including:

- BioMarin and certain of its current and former executives in a securities class action alleging the company
  made false or misleading statements regarding one of its gene therapy candidates; the court dismissed all
  claims, and the dismissal was affirmed by the US Court of Appeals for the Ninth Circuit
- Good Technology and former directors and officers in successfully resolving shareholder litigation in the Delaware Court of Chancery involving breach of fiduciary duty and appraisal claims arising from the sale of the company to BlackBerry
- NewLink Genetics and former directors and officers in successfully resolving a securities class action in the US District Court for the Southern District of New York and the US Court of Appeals for the Second Circuit in relation to the announcement of phase III trial results
- NVIDIA and certain of its executives in a securities class action arising from a market cap loss of \$35
   billion over a three-month period in late 2018
- Stitch Fix and certain of its former officers in a class action arising out of a stock price decline following
  the company's Q4 2018 earnings call; the court dismissed all claims with prejudice, and the dismissal was
  affirmed by the Ninth Circuit
- Tableau and certain of its officers for alleged securities fraud following a nearly 50% stock drop after the company announced disappointing results for Q4 2015; following discovery, the class action was mediated and settled on favorable terms
