She also maintains a robust pro bono practice, with a particular focus on criminal justice and immigration.

Sam has successfully represented clients in the life sciences and technology industries, including:

Law's Federal Appellate Litigation Clinic, she obtained habeas corpus relief for her client after briefing and arguing the case before the US Court of Appeals for the Sixth Circuit.
