Rod is an international products lawyer with more than 25 years of experience supporting the world's top and most innovative companies with their product liability, product compliance and product safety issues. He is routinely ranked as a leader in major legal directories, where he has been described as an 'outstanding go-to specialist for product liability matters', 'one of the top product liability and product regulatory experts worldwide', and 'without a shadow of a doubt, the most knowledgeable product liability lawyer in the European space'.
